





2. PRAY FOR COURAGEOUS CHURCHES

Pray that pastors and congregations will stand unashamedly upon the Word of God, even in the face of growing cultural opposition. *"Watch ye, stand fast in the faith, quit you like men, be strong."* (I Corinthians 16:13)

3. PRAY FOR LAWMAKERS AND LEADERS

Ask God to give wisdom to those in authority and to raise up leaders who value righteousness over popularity. *"Righteousness exalteth a nation: but sin is a reproach to any people."* (Proverbs 14:34)

4. PRAY FOR CHRISTIAN FAMILIES

CASE FILES OF FAITH: WHAT YOUR SUPPORT MADE POSSIBLE REAL VICTORIES. REAL BELIEVERS. REAL RESULTS—BECAUSE YOU CARE.

- **OUTDOOR WORSHIP RESTORED**

A church in Georgia was told it needed a costly permit to sing Christmas carols downtown. After CLA intervened, city officials reversed course, allowing the event to continue freely.

- **STUDENT SPEECH PROTECTED**

In Kentucky, a high school senior was told she could not include a Bible verse in her graduation speech. CLA helped the school understand her constitutional rights—and she spoke boldly for Christ.

- **CHURCH ZONING VICTORY**

A congregation in Texas faced zoning restrictions preventing them from expanding their sanctuary. After legal counsel from CLA, the city approved the project.

PRAYER CHECKLIST

- **ALABAMA:** Pray for a pastor seeking legal help after being told his church cannot distribute gospel tracts at a community parade.
- **ALASKA:** Pray for a Christian school defending its right to hire teachers who agree with its statement of faith.
- **ARIZONA:** Pray for a Christian doctor disciplined for offering to pray with a patient.
- **ARKANSAS:** Pray for a small-town church facing local resistance to operating its bus ministry.
- **CALIFORNIA:** Pray for a Christian college under pressure to remove faith-based admissions standards.
- **COLORADO:** Pray for a Christian student suspended for reading her Bible during a silent reading period.
- **CONNECTICUT:** Pray for a Christian-owned business facing a city citation for displaying Scripture verses on company property.
- **DELAWARE:** Pray for a church whose weekly Bible study was denied a room rental at a local library.
- **FLORIDA:** Pray for a Christian teacher disciplined for referencing Scripture while encouraging students to act with kindness.
- **GEORGIA:** Pray for a church seeking counsel after city officials restricted its outdoor Christmas outreach.
- **HAWAII:** Pray for a Christian ministry threatened with fines for feeding the homeless without a commercial license.
- **IDAHO:** Pray for a pastor fined for holding an outdoor baptism service at a public park without a permit.
- **ILLINOIS:** Pray for a Christian business owner facing legal pressure after declining to work on Sundays.
- **INDIANA:** Pray for a Christian student prevented from distributing invitations to a youth revival on school grounds.
- **IOWA:** Pray for a Christian chaplain removed from a public safety training program for sharing his testimony.
- **KANSAS:** Pray for a Christian college being challenged for requiring chapel attendance.
- **KENTUCKY:** Pray for a Christian school facing scrutiny after beginning each day with prayer over the intercom.
- **LOUISIANA:** Pray for a church dealing with restrictive sound ordinances limiting worship music volume.
- **MAINE:** Pray for a Christian radio station struggling with new state licensing requirements.
- **MARYLAND:** Pray for a pastor denied a city permit for a public prayer rally.
- **MASSACHUSETTS:** Pray for a Christian teacher facing disciplinary review for posting a Bible verse in her classroom.
- **MICHIGAN:** Pray for a Christian daycare owner cited for including Bible story time during regular hours.
- **MINNESOTA:** Pray for a church prevented from renting a public school auditorium for Christmas services.
- **MISSISSIPPI:** Pray for a Christian student prohibited from wearing a "Faith Over Fear" T-shirt.
- **MISSOURI:** Pray for a Christian nursing home threatened with inspection penalties for hosting weekly worship services.
- **MONTANA:** Pray for a Christian rancher fined for displaying Scripture banners along a county road.
- **NEBRASKA:** Pray for a Christian business owner seeking help after being denied a permit to host a prayer breakfast.
- **NEVADA:** Pray for a street evangelist arrested for sharing the gospel on a public sidewalk.
- **NEW HAMPSHIRE:** Pray for a Christian librarian under review for maintaining a "Faith and Freedom" display.
- **NEW JERSEY:** Pray for a pastor warned not to preach on public property near a county courthouse.

- **NEW YORK:** Pray for a Christian nonprofit challenged over its religious employment policy.
- **NORTH CAROLINA:** Pray for a church facing city restrictions for operating a free after-school Bible club.
- **NORTH DAKOTA:** Pray for a Christian radio broadcaster threatened with shutdown over outdated local regulations.
- **OHIO:** Pray for a Christian teacher investigated after quietly praying with coworkers before class.
- **OKLAHOMA:** Pray for a small church threatened with eviction for operating in a rented storefront.
- **OREGON:** Pray for a Christian counselor being pressured to withhold Biblical advice in sessions.
- **PENNSYLVANIA:** Pray for a Christian campus group denied recognition for requiring its leaders to affirm Biblical principles.
- **RHODE ISLAND:** Pray for a Christian police officer reprimanded for posting Scripture on his locker.
- **SOUTH CAROLINA:** Pray for a church facing public opposition to holding revival meetings in a city park..
- **SOUTH DAKOTA:** Pray for a Christian homeschooling family seeking help after being accused of "non-compliance" with vague reporting rules.
- **TENNESSEE:** Pray for a pastor questioned by officials for holding prayer meetings in a public pavilion.
- **TEXAS:** Pray for a Christian school under investigation for refusing to remove crosses from classroom walls.
- **UTAH:** Pray for a missionary group denied access to a public university campus event.
- **VERMONT:** Pray for a Christian family facing legal action for hosting community Bible studies in their home.
- **VIRGINIA:** Pray for a Christian postal worker denied time off to attend Christmas Eve services.
- **WASHINGTON:** Pray for a Christian small business owner fined for closing on Sundays to observe a day of rest.
